HOPE Dixie National Color Bonanza High Point Award Qualifications, Prizes, and Rules.

NASMDA Mule: YOUTH 18 & UNDER, SILVER AMATEUR, AMATEUR, OPEN (JR/SR Combined) awarded to qualified competitors. **Open (All Ages Equine)** goes to the mule having the most points in the Open division regardless of the number of exhibitors. They **MUST** show in a halter and a minimum of three (3) riding classes. This mule will be awarded the **NASMDA High Point Mule Saddle**. Youth 18 & Under, Silver Amateur, and Amateur: it is an equine/exhibitor combination who **MUST** show in halter and a minimum of three (3) riding classes. Only points earned in that specific division will apply. 4 total awards

NASMDA Donkey: OPEN DONKEY, AMATEUR DONKEY (W/T), TRAINING LEVEL DONKEY awarded to qualified competitors. **Open Donkey** goes to the donkey having the most points in the Open division regardless of the number of exhibitors. They **MUST** show in a halter and a minimum of (3) riding classes. Amateur Donkey and Training Level Donkey: it is an equine/ exhibitor combination who **MUST** show in halter and a minimum of three (3) riding classes. Only points earned in that specific division will apply. 3 total awards

ARHA Division: NOVICE YOUTH, YOUTH 18 & Under, NOVICE AMATEUR, AMATEUR, OPEN (All Ages Equine) awarded to qualified competitors. **Open (All Ages Equine)** goes to the ARHA Open Horse having the most points in the Open division. They **MUST** show in conformation and a minimum of three (3) riding classes. This horse will be awarded the **Dixie National ARHA Hi Point Belt Buckle**. Novice Youth, Youth 18 & Under, Novice Amateur, Amateur: it is a horse/exhibitor combination who must show in conformation and a minimum of three (3) riding classes. Only points earned in that specific division will apply. 5 total awards

PHBA Division: YOUTH W/T 18 & Under, YOUTH 18 & Under, AMATEUR W/T, AMATEUR, SELECT AMATEUR, OPEN (All Ages Equine) OPEN HALTER/COLOR, PALOMINO BRED (PB) awarded to qualified competitors. **OPEN** goes to the PHBA Open Horse having the most points in the Open division. They must show in conformation or halter and a minimum of three (3) riding classes. This horse will be awarded the **PHBA High Point OPEN Saddle**.

YOUTH 18 & Under and AMATEUR: it is a horse/exhibitor combination who must show in conformation or halter and a minimum of three (3) riding classes. Only points earned in that specific division will apply. Each of these horses will be awarded a **PHBA High Point Saddle**.

PALOMINO BRED (PB) goes to the PHBA Open Horse having the most points in the Open division. They must show in conformation or halter and a minimum of three (3) riding classes. This horse will be awarded the **Dixie National Palomino Bred Hi Point Belt Buckle**.

YOUTH W/T 18 & Under, AMATEUR W/T, SELECT AMATEUR: it is a horse/exhibitor combination who must show in conformation or halter and a minimum of three (3) riding classes. Only points earned in that specific division will apply. **EXCEPTION** High Point Halter Color must show in both Halter **AND** Color and only those points will apply. 9 total awards

OPEN HORSE (All Ages Equine): awarded to qualified competitors. **OPEN** goes to the Open Horse having the most points showing in any OPEN division. They must show in conformation or halter and a minimum of three (3) riding classes. This horse will be awarded the **Dixie National OPEN Hi Point Belt Buckle**. 1 total award

High Points and/or All Arouns will be calculated on each judge's placing based on each association's point scale. All divisions will be based on a one equine/one competitor combination except open which is based on equine only. Tie breaker information is located in the show office.



IMPORTANT INFORMATION:



- The MS Board of Animal Health requires that ALL equines entering the MS Fairgrounds, that are 12 months of age or older must have & present a current (12 months) negative EIA (Coggins) report AND a 30-day Certificate of Veterinary Inspection (Health Certificate) Original only, NO PHOTOCOPIES accepted. Certificates will be checked at Gate 14 (Livestock Gate).
- **Trailers:** All trailers, loaded or empty, must enter and exit ONLY through Gate 14.
- **Shavings:** Shavings must be purchased through the Fairgrounds shavings office. No outside shavings allowed per MS Fair Commission. Shavings must be paid for before delivery. NO EXCEPTIONS.
- **RV hook ups:** RV hook ups are available upon arrival at the Fairgrounds and not reserved through HOPE Palomino and the Dixie National Color Bonanza show. They are available on a first come, first served basis.
- **Stalls:** Reservations are being taken now with payment. **No stalls will be reserved without payment. TO STALL AS A GROUP**, reservations MUST be sent together. If mailed, in one envelope, with full payment for stalls and one person designated as "Stall Agent." Multiple checks or money orders as payment will be accepted as long as all information and payment is provided in one envelope or in one email (contact stalling agent for contactless payments). Refunds of entry & stall fees will only be considered in the event of death or serious injury of the equine entered. A signed and dated vet certificate must be presented at the show office no later than 5:00 PM on the afternoon prior to the first class entered. Any occupied stall is NON-REFUNDABLE. Refunds will be sent to the agent who paid the fee (s). NO refunds for scratched entries. Once a stall has been occupied, you will NOT be allowed to move!
- **Motorized Vehicles- Restrictions:** In accordance with Mississippi Fair Commission, no small motorized vehicles except golf carts are allowed on the fairgrounds. ALL vehicles, INCLUDING GOLF CARTS, must be operated by a licensed driver.
- **Parking:** Exhibitors may only park in the designated areas. Vehicles in FIRE LANES or NO PARKING AREAS will be towed. All fines and towing fees are at the owner/operator's expense.
- **Interpretation of Rules:** The right to settle all questions or disputed incidents at the Dixie National Color Bonanza is reserved by the HOPE Show Manager or designated representative. All exhibitors or other participants, as a condition of admission, consent to such method and agree to be bound thereby by their entry form.

Additional Information

Entries close **January 10, 2024**. All mailed entries must be post marked by **January 5, 2024**, and emailed entries payment information sent by January 10, 2024. ANY ENTRIES AFTER JANUARY 10, 2024, WILL BE ASSESSED APPLICABLE LATE FEES.

Mailed entries may be paid by check, cash, or money order. Emailed entries processed via PayPal. Contact the show manager for more details. Checks or money orders made out to HOPE Palomino. All forms of payment are to be in U. S. funds. Entries are not officially made until payment clears. A \$50 processing fee will be charged for any returned check. Late entries are accepted at the show office during the show only. The penalty for a late entry at the show is \$50 per horse. All late fee entries must be received no later than one (1) hour before the first class of the day.

3. Copy of show record or ROM proof for Performance Halter.

(1-4 Major Faults 5-7 Average Quality 8-10 High Quality)

- Riders should pick up and balance the horse into the bridle during the transitions.
- Establish an average score for each gait and score horses above or below this standard.
- Include the transitions in your evaluation of the gait in which the horse is going toward.
- Be ready to call a walk score before the horse trots. The pattern is fast. Keep your average in mind and work up and down from there both ways.
- Spread your scores when the performance warrants.
